Through this program, Foothills provides the following services: (1) coordinating multidisciplinary teams (MDTs) of local government and nonprofit agencies to increase communication and mutual accountability, reduce duplication of services, and help ensure that children are safe and that their needs are met; (2) conducting coordinated forensic interviews that reduce the number of times a child is interviewed and so reduces the child's trauma and that provide accurate information that helps the team to make decisions in the best interest of the child; and (3) providing ongoing support, assessment, and referral services for the families to help them create and maintain safe, healing environments for their children.

Public Education and Outreach Program:

Through public education and outreach, Foothills increases community understanding of the ways to prevent and stop child abuse and neglect. Foothills offers the nationally recognized Stewards of Children child sexual abuse training, the locally developed Stand Up for Kids! mandated reporter training, and other customized trainings free of charge to organizations and concerned adults in the community.

Training for Professionals:

Through this program, Foothills provides MDT members and other local professionals who work with child victims training on best practices in serving child victims and their families, for example, in trauma-focused, evidence-based therapy or about the medical needs of children who have been sexually exploited.
