**Child Victims Health Care Access Program:**

The Child Victim's Health Access Program increases access to appropriate health care for child victims of abuse. On April 1, 2018, Foothills' new medical director began duties to provide forensic medical evaluations to child victims on site at Foothills. 117 children were offered medical services, regardless of access to insurance or ability to pay, which is a best practice, according to the National Children's Alliance (2017). Forensic medical evaluations support legal decision-making; screen for injuries/medical conditions and initiate medical treatment; diagnose sexual and physical abuse and neglect; and reassure victims and parents about the child's physical well-being (Walsh et al, 2007).

**Public Education and Outreach Program:**

Foothills increases community understanding of the ways to prevent and stop child abuse and neglect by offering the nationally recognized Stewards of Children child sexual abuse prevention training, the locally developed Stand Up for Kids! mandated reporter training, and other training free of charge to parents, grandparents, and other concerned adults and to staff at youth-serving organizations. In FY 2019, 944 adults completed training offered by Foothills.
